Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ol style="list-style-type: none"> 1. Social Security number and income 2. Credit history and credit scores 3. Account balances and payment history
How?	We collect your personal information, for example, when you: <ol style="list-style-type: none"> 1. Apply for a loan or give us your employment history 2. Give us your income information or provide account information 3. Provide employment information We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

Why can't I limit <u>all</u> sharing?	Federal law gives you the right to limit only <ul style="list-style-type: none"> • Sharing for affiliates' everyday business purposes – information about your creditworthiness • Affiliates from using your information to market to you • Sharing for non-affiliates to market to you <p>State Laws and individual companies may give you additional rights to limit sharing.</p>
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. Does not have affiliates
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. Does not share with nonaffiliates so they can market to you.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Doesn't jointly market.
